1. All parties listed on this document agree that Gold Medal Collectibles (GMC) will act as their agent for the sale of Olympic memorabilia per the terms and conditions on the Consignment agreement.
2. The Consignor agrees to submit to GMC a signed copy of this agreement. In the event that the consignor fails to submit a signed agreement, GMC will consider this agreement null and void and the item(s) will not be placed in the auction.
3. Consignor guarantees absolute ownership of the items submitted for auction.
4. Consignor guarantees that there are no liens on the items submitted for auction.
5. Consignor guarantees that all items submitted for auction are genuine and authentic Olympic memorabilia. GMC reserves the right to seek an expert opinion on any item submitted for auction. All costs associated with the opinion will be the responsibility of the Consignor.
6. GMC reserves the right to photograph each consigned item in accordance with GMC standards and upon the Consignor's request. Consignor must submit payment for all requested photography **in advance**.
7. GMC reserves the right to refuse or reject any item in whole or in part.
8. GMC will ***not*** accept any reserved bids placed by the Consignor. Once an item is consigned, it will remain in the custody of GMC until the completion of the auction and ***Unsold Lots*** phase; therefore, it may not be withdrawn by the Consignor until the conclusion of the auction.
9. The buyer's fee charged to successful bidders will be retained by GMC.
10. The auction catalog will be mailed to active Bidders and Consignors on the GMC - Auction mailing list. Additional auction catalogs will be available to those requesting them at a nominal charge at the discretion of GMC.
11. All items will be sold in accordance of sale as published in the auction catalog.
12. GMC reserves the right to refuse or reject any fragile items (ie., glass) submitted for auction. It will be the responsibility of the Consignor to insure shipment of any fragile items between the Consignor and GMC.
